OLD BUSINESS

A. Wellhead Protection Plan Implementation – Changes made in the wording under the Wellhead Protection Plan 4.07 REGULATIONS

- #9C Jane questioned whether this item should be changed to say, "flammable substances stored on the premises instead of within the building."
- #9E Change the word "City" to "Village"

 Jim Truxton stated 9E may conflict with state building regulations for roof runoff. He was not sure and just suggested we mark it for review.
- #9F Jeremy questioned if we had already discussed omitting this. Jim Truxton offered that our village ordinances cover territory up into Webber Twp and since they do not have this in place, it may be better to keep as a guideline.
- #9G 1. 9G #1 Change " maintained" to "inspected" and the "Whatcom" to " District 10"

 Thought it was District 10 Health Dept but not sure.
 - 2. Change "Public Works Director" to "District 10 Health Dept."

Jane asked if anyone had any other discussion on the wellhead protection. Tammy went back to #9F and questioned again if we had already approved removing this and it was again stated it covers areas outside the village in Webber Twp and is best to keep it.
