Minutes:

# Sheriff Report:

- Sheriff Martin reported to the Village Council, former Deputy Reserve Officer Dr. Pressley "Doc" passed away, and will be sorely missed by the dept, and all who knew him.
- The sheriff also gave an update on the TRV center, there have been talks, of possibly becoming a Regional Facility, which would mean intake from other areas of the state. the management of facility may fall to the County, State, or Court system. There will need to be extensive

renovations to the building, Grant applications to the state have begun, in hopes of acquiring approx. \$10,000,000.00 to complete the necessary renovations, and begin staffing the facility.

- Sheriff Martin also reported the merging of Elk, Sauble and Eden Townships fire departments. And the opening of a "Base" Department, with the original departments becoming substations
- The sheriff also stated there will be reserve deputies heading for 120 hour training classes, giving the department extra man power to police the growing ORV trails, and the ability to write citations when necessary.
- He also commented about the recent fatal car crash in Chase, and the addition of speed control, equipment, that allows the department to photo, document and follow up on offenders. There will be more control equipment set ups in the near future.

# Attorney Report:

• There were no attorneys in attendance.

# Commissioner Welford:

- Commented on new speed control devices.
- Wondered why striping on Mich. Ave was changed when it got paved. President Truxton explained it was to slow traffic, statistics show merging into one lane through a busy section of town, has greatly reduced accidents and pedestrian injuries.
- Commissioner Welford discussed with the council the need to change speed limits, or stop signage on the east side of 8<sup>th</sup> St. Bridge, to slow traffic through the curves leading up to the new bridge, when it opens.

# Payment of Bills:

• The bills were presented to the Village Council for payment for the month of March, 2023, a motion was made by C. Vicent, and supported by C. Miller. A roll call vote was taken. President Truxton, Aye., C. Miller, Aye, P. Anderson, Aye and C. Vicent Aye. All Ayes, 0 Nays, 1 absent, Motion carried.
