The market may offer seasonal/holiday events depending on vendor availability and demand. Our 'Up North' themed market offers residents and visitors the opportunity to explore and meet area farmers, food producers, makers and artisans of all sorts, while connecting with community organizations, clubs, service providers and area businesses hosting demonstrations, events, classes and more. Our market increases access to fresh, affordable, healthy food choices and activities, while strengthening the local economy, building community and providing a welcoming gathering place.

VENDOR Application

Please complete the Vendor Application below to begin the process of vending at the Pure Marketette, Baldwin's Best Outdoor Market. Once you submit this application, you will receive an email with further information and 'next steps'. Please note the following:

- A sales tax license is required for any vendor selling non-food items. Visit www.michigan.gov/taxes or call 517-335-7508 to obtain a license.
- Cottage Food vendors must comply with all state laws and must submit proof of training.
- A nominal vendor booth fee of \$10 must be paid by Friday of the week prior, or save time with the seasonal fee of \$100, payable by June 1, 2024.
- All vendors must agree to comply with our rules and regulations to ensure market goes safety and satisfaction.
- Vendors may only sell products grown, produced or made in Michigan, preferably as close to Lake County as possible.
